## OBWIESZCZENIE

w sprawie przepisania obiektu do księgi rejestru zabytków nieruchomości województwa zachodniopomorskiego i nadania nowego numeru rejestru

Zachodniopomorski Wojewódzki Conservator of Monuments in Szczecin informs, that the object, i.e. the Strzeżewa site, entered into the register of monuments by the decision of the Provincial Conservator of Monuments in Szczecin, sign: KL-V-0/95/56 of June 18, 1956, under no. 105,

was transferred to the register of monuments of the voivodeship of Szczecin to the register of monuments of the voivodeship of Zachodniopomorskie under a new registration number

**as the Strzeżewa site, located in the locality of Strzeżewo, gm. Kamień Pomorski, pow. kamieński.**

ZWKZ in Szczecin informs, that in accordance with art. 140 pkt. 1 and art. 142 of the Act of July 23, 2003 on the protection of monuments and care for them (Dz. U. z 2022, poz. 840 with amendments) decisions on entry into the register of monuments, whose originals are in the possession of the provincial conservator of monuments, retain their legal force, i.e. remain in legal force. However, this notice informs about the assignment of a new registration number, subordinate to the object, without changing the content of the decision. The rules of the register of monuments are defined by the Act on the protection of monuments and care for them of July 23, 2003 and the decision of the Minister of Culture and National Heritage of May 26, 2011 in the matter of the conduct of the register of monuments, national, voivodeship and municipal registers of monuments and the national list of monuments stolen or exported across the border in violation of the law.
